

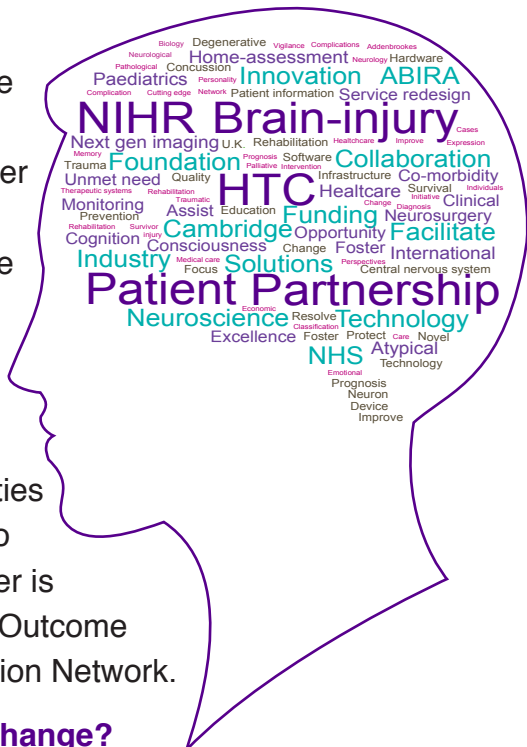

The NIHR Brain Injury Healthcare Technology Co-operative (HTC) has developed a volunteer register for patients, carers and other interested persons to assist in the development and advance of healthcare technologies. Registering an interest ensures that interested parties receive information about the HTC activities and be notified of opportunities to take part in research. This register is delivered in partnership with the Outcome Registry Intervention and Operation Network.

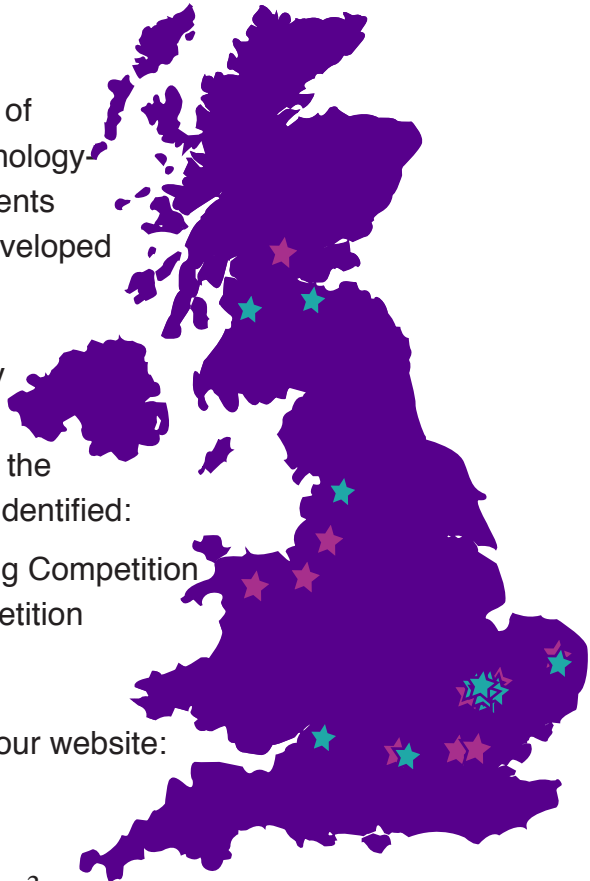
